DESIGNATION AS EXPORT FORWARDING AGENT

Check Appropriate: Individual Partnership Corporation Sole Proprietor Limited Liability Company

Know all men by these presents that doing business as under the laws of the State of residing or, having an office and place of business at hereby constitutes and appoints,

Argents Air Express, Ltd. its officers, employees, and/or specifically authorized agents, to act for and on its behalf

as a true and lawful agent and attorney of the grantor for and in the name, place, and stead of said grantor, from this date and in the United States and its territories, either in writing, electronically, or by other authorized means to make, endorse, sign, declare, or swear to any declaration, certificate, bill of lading, carnet or other document required by law or regulation in connection with the transportation, or exportation of any merchandise shipped or consigned by or to said grantor; to perform any act or condition which may be required by law or regulation in connection with such merchandise; to receive any merchandise deliverable to said grantor;

To make endorsements on bills of lading conferring authority to transfer title, to make, sign, declare, or swear to any statement, certificate, or any other affidavit or document which may be required by law or regulation, regardless of whether such document is intended for filing;

To sign, seal, and deliver for and as the act of said grantor any bond required by law or regulation in connection with the merchandise exported, or in connection with the lading, unloading or navigation of any vessel or other means of conveyance owned or operated by said grantor, and any and all bonds which may be voluntarily given and accepted under applicable laws and regulations, declarations or affidavits in connection with the export of merchandise;

To sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the lading, unloading, or operation of any vessel or other means of conveyance owned or operated by said grantor;

To authorize other duly licensed forwarders within the territory, to act as grantor's agent; if the grantor is a nonresident of the United States, to accept service of process on behalf of the grantor;

Grantor authorizes the above Grantee to act within the territory as lawful agent to sign or endorse export documents (i.e., commercial invoices, bill of lading, insurance certificates, drafts and any other document) necessary for the completion of an export on grantor's behalf as may be required under law and regulation in the territory and to appoint forwarding agents on grantor's behalf;

And generally to transact business including filing of claims pursuant to grantor's request in which said grantor is or may be concerned or interested and which may properly be transacted or performed by an agent and attorney. Grantor undertakes to determine any export license requirements, to obtain any export license or other official export authorizations, and to carry out any formalities required by United States government agencies for the its export of goods.

Giving to said agent and attorney full power and authority to do anything whatever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these presents;

This power of attorney to remain in full force and effect until notice of revocation in writing is duly given to and received by grantee.

Grantor acknowledges receipt of Argents Air Express, Ltd. Terms and Conditions of Service governing all transactions between the Parties.

If the Grantor is a Limited Liability Company, the signatory certifies that he/she has full authority to execute this power of attorney on behalf of the Grantor.

¹ Check box that applies to the company

² The full legal name of person, company, or entity granting authority.

³ Indicate in the same manner, as checked in field one (1).

⁴ The name of the State where company is incorporated, or if other than a corporation the State in which the entity is operating as a business, or resides as an individual.

⁵ The full legal address of company or entity granting authority.

⁶ Indicate the full legal name as indicated in field two (2).

⁷ The signature of individual, sole proprietor, partner, or LLC Partner, or in case of a corporation, the signatory must be an officer of the corporation, or an individual duly authorized to sign legal documents on behalf of the corporation. The offices of President, Vice-President, Secretary and Treasurer are automatically assumed to have legal authority. If the signatory does not hold one of these named offices, copies of the Articles of Incorporation, or a Resolution of the Corporate Board of Directors must be attached to support the individual's authority to sign.

⁸ State the capacity of person signing in field seven (7) above.

⁹ This is a mandatory field for Non-Resident entities. For all others this field is optional.

¹⁰ This is an optional section for individuals, partnerships, or some limited liability companies.
